- You will automatically receive **three bottles** of Krupp Brothers wines sent in **three shipments** each calendar year (spring, fall, winter).
- You will be the first to receive new releases and have the only opportunity to receive select library wines.
- Members receive 15% off on all additional wine purchases any time of year.
- You can purchase up to double the amount of allocated wines.
- Members are entitled to VIP tours of Stagecoach Vineyard and our private tasting room (tours by appointment only by calling 707-226-2215).

**Cost:** Wines will cost between \$125 and \$200 per shipment, depending on the wines selected for the program. Sales tax (when applicable) and shipping charges will apply. Your credit card will be charged at the time of shipment.

Membership term is indefinite and can be cancelled at any time following your first shipment. 1-year gift memberships are also available. Please note that we can only ship to the following states: AK, AZ, CA, CO, DC, FL, IL, IA, HI, LA, MA, MI, MN, MO, NE, NV, NH, NJ, NM, NY, NC, ND, OH, OR, TX, VA, WA, WI, and WY. Members must be at least 21 years of age.

### Estate Club Terms & Conditions

Please complete the Membership Form in its entirety.

- Membership Terms** – Members will receive three (3) Krupp Brothers Estates wines shipped to them three (3) times a year (approximately January, May and September). Membership term is indefinite, except for 1-year gift memberships. Member's credit card will be charged cost of wines, plus shipping and sales tax (if applicable) at time wine ships from warehouse. Member may cancel membership at any time after receiving first shipment. Krupp Brothers Estates may cancel membership at its discretion. Members will receive 15% off the winery price of any additional wine purchases anytime of year (quantity limits may apply). Members must be at least 21 years of age.
- Sales Tax** – State laws require us to collect sales tax for shipments to the following states (Local Sales Tax = sales tax in the city/county you reside): AZ 8.05%, CA 7.75%, DC 9%, HI 4%, LA 4%, MI 6%, NJ 7%\*\*\*, NY Local Sales Tax\*\*\*, ND 7%, NV Local Sales Tax, NC Local Sales Tax\*\*\*, OH Local Sales Tax\*\*\*, TX 6.25%, VA Local Sales Tax, WA Local Sales Tax\*\*\*, WI 5.6%.  
\*\*\*NY, NJ, NC, OH, and WA residents: Sales tax is charged AFTER adding the shipping/handling charges, per state requirements.

- Shipping and Handling** – Use this table to calculate shipping and handling charges:

Krupp Brothers can ONLY ship to the states listed in the table above. Rates are for standard ground shipping. Shipping rates are subject to change without notice. If you live in a state that prohibits direct shipment of wine to private individuals, you will need to provide an acceptable alternate shipping address. **Pick-up of wine at our office can be arranged at no charge.**

\*\*Notes on shipping: If we can negotiate a less expensive shipping cost, we will subtract that amount from your charges. Wine will be sent via standard ground shipping. Please call or email us for special shipping options (express delivery, etc.).

- Please complete all delivery and billing information.** Please print legibly. Signature required for delivery. Business address is preferred for delivery. *Alcoholic beverages can be sold and delivered only to persons who are at least 21 years of age.* Payment for Estate Club membership is by credit card only.
